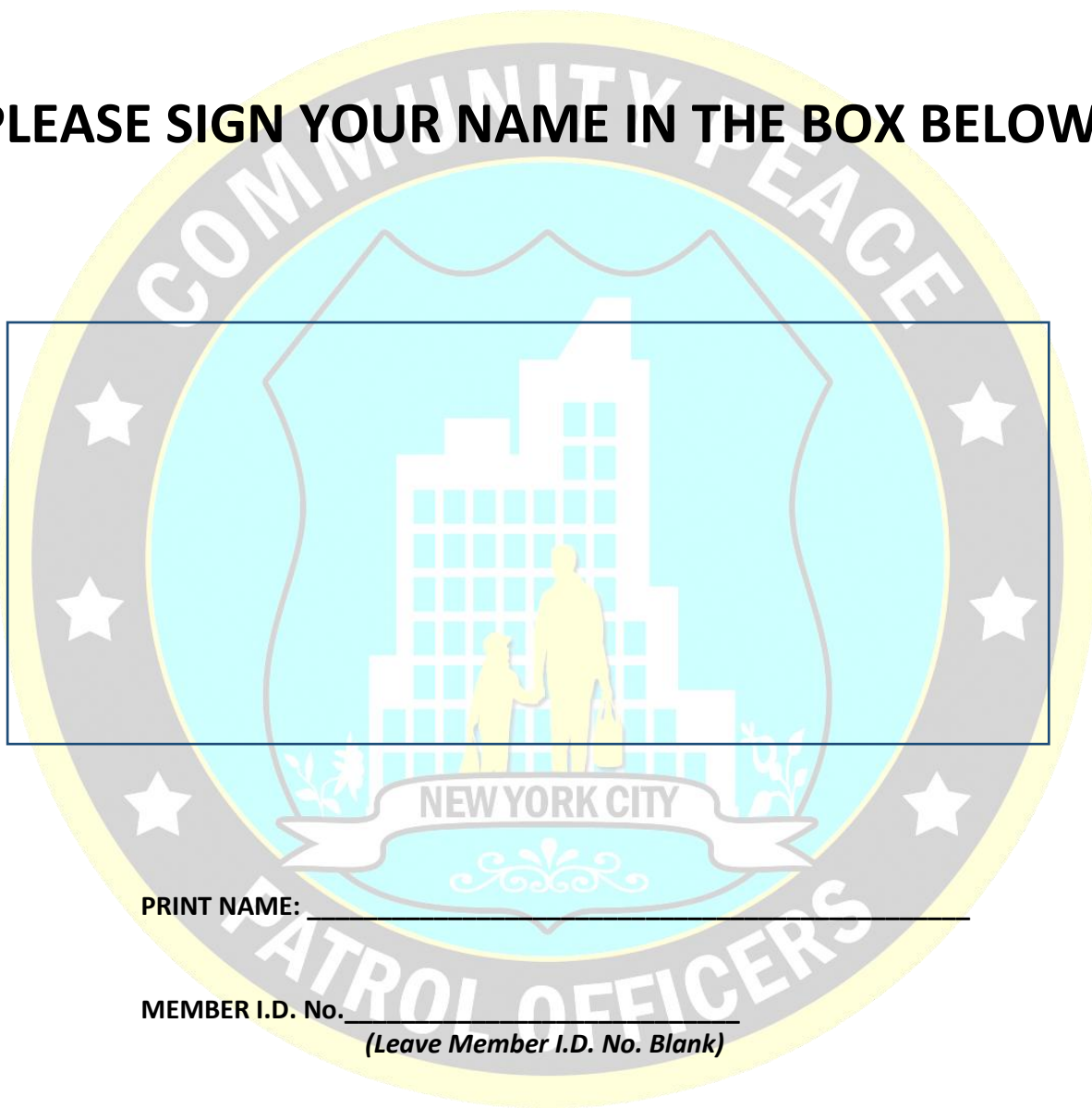

9. Your membership will be terminated if you knowingly provide false information.
10. First Aid/CPR/AED Certifications must be kept up to date.
11. Use of lights and sirens, and the installation of such equipment in your vehicles must be approved and sanctioned by NYCCPPO.
12. Always identify yourself properly to the authorities when necessary and/or if required of you.
13. Use your credentials correctly. If you do not know how to use them correctly—ask.
14. Your ID card may be used on its own. Badges/Shields must be accompanied by your ID card at all times.
15. Shields are licensed separately for an additional fee that is not included in the cost of the training.
16. Lost or stolen I.D. cards or shields must be reported to the Police immediately. A copy of the Police Report must be filed with NYCCPPO as soon as it is obtained.
17. Replacement badges may be licensed from the NYCCPPO for a fee of \$150 (fee subject to change w/o notice).
18. There is an annual fee of \$25 to renew your ID Card (fee subject to change without notice).
19. Replacement ID Cards may be obtained from NYCCPPO for a fee of \$35 (fee subject to change without notice).
20. Do not lend your credential to anyone.
21. Do not misuse your credentials or misrepresent yourself.
22. Do not alter or change your credentials in any way.
23. Do not use your credentials to obtain favors from anyone, to obtain free public transportation, or to trespass.
24. Membership donations in the amount of \$25 will be collected at every quarterly meeting or four (4) times a year whether you attend the meeting or not.
25. Dress conservatively when performing your peace patrol duties.
26. When dispatched please notify NYCCPPO as soon as possible as to whether you can respond or not.



## CODE OF ETHICS

- 
- The seal of the Community Peace Patrol Officers is a circular emblem. It features a central shield with a light blue background. - Report to whoever is in charge within the Institution or Incident Command System.
  - Adhere to Institutional or Incident Command System rules & regulations at all times.
  - Identify and solve immediate concrete problems.
  - Meet, accept, and respect persons exactly as they are.
  - Recognize normal stress reactions and find or make referrals to resources who will address the immediate problems.
  - Do no harm—never exploit a vulnerable person reacting to a traumatic event.
  - Protect Confidentiality.
  - Respect social diversity and cross-cultural settings.
  - Function at levels appropriate to your training and educational background.
  - Know the available resources and assistance and mental health referral protocols.
